Preceptorship is the front door welcome which encourages belonging at a national level - consistency for a workforce.


Sense of belonging

- 20 organisations are currently pending








Interim Quality Mark - applications by region

Timeframes

- Expectation that all organisations will meet core standards by September 2023
- The Interim Quality Mark will be available until March 2024
- Final applications to be received by NPP team by end January 2024



Learning from the Baseline Assessment

- Excellent engagement from a wide variety of organisations from all regions with commitment to preceptorship
- 53% organisations compliant with National Preceptorship programme
- 94% organisations have a current preceptorship programme.
- Organisations currently reviewing, refreshing programmes and preparing for Gold Standard
- Organisations are already using resources including development masterclass
- Revitalised passion for preceptorship amongst organisations



Learning from the Baseline Assessment

- 94% have a preceptorship programme
- 69% have a preceptorship policy
- 87% have allocated lead for preceptorship
- 11% have preceptorship champions
- 100% meet minimum requirement of six months
- 50% have minimum supernumerary and 5% have none
- 94% preceptees and 48% preceptors have protected time
- 67% provide initial training and 37% ongoing support
- 93% have structured learning programme for preceptees

First Year Review

- Assess status of Preceptorship eight months after launch of National Framework and resources
- Comparison with baseline review one year on
- Identify and share best practice within communities of practice
- Provide support to organisations requiring additional support
- 30 May <u>survey</u> available for Preceptorship Leads to complete (one per organisation)
- 30 June final date for submissions
